Pets in School Policy

1.0 Introduction

King William's College and the Buchan School (the School) recognises that in some controlled circumstances the presence of pets on site can be beneficial to the well-being of pupils and staff, increasing their understanding of responsibility and developing empathy and nurturing skills. The development of these skills is a key part of the School's personal, health and social education curriculum. They also provide benefits for children taking enjoyment from interaction with pets and other animals. They can be an important part of life for many families and are often included in day-to-day activities such as walking children to and from the School. Members of staff who are resident on site may also choose to own pets, which therefore spend most of their time within the school boundaries.

The purpose of this policy is to provide guidance for staff, pupils, parents, visitors and contractors regarding pets on the campus for the following purposes:

- Accompanying parents/guardians whilst dropping off and picking up their children;
- Pets living in residential accommodation;
- Staff, visitors and contractors;

However, pet owners must be aware that pets are potentially dangerous and may also be a health hazard. They must also be mindful of the fact that some children and adults do not like pets and may be afraid of, or allergic to them.

It is envisioned that on some occasions, pets will be brought onto the premises. On these, as on any other occasions, as a school, the welfare of the students, staff and visitors is paramount.

Dogs may be brought into School by outside agencies for example Guide Dogs for the Blind, Police, Pets as Therapy and rescue charities from time to time.

2.0 Risk of Pets on the Campus

The School recognises that there are risks in allowing pets onto the campus, including biting incidents, barking dogs which may frighten children and hazards to health such as Toxocariasis. Parents and staff may understandably have concerns regarding pets on the campus.

It is the School's aim to control risks by asking staff, parents, guardians, visitors and contractors to follow some simple rules, exercise common sense and encourage sensible behaviour of pupils around pets.

3.0 Legislation

The School is required to comply with all legislation including, and not limited to, the Health and Safety at Work Act 1977 and the Health and Safety at Work Order 1998. This legislation establishes the standards that must be met to ensure the health and safety of all employees and others (students, parents, guardians, contractors and visitors) who may be affected by any school activity and are enforced by the Health and Safety Executive.

4.0 Bringing Pets on to the School Campus

The School has no jurisdiction regarding dogs walked through the School grounds using the public footpath. Anyone bringing a dog on to the campus must ensure that they are on a lead, supervised at all times and controlled so that it does not jump up at people.

Any pupil interaction with the pets must be properly supervised by the owner. Pupils must never to be left alone in charge of the pet, unless permission is given by parents or guardians to do so and they are able to adequately control the pet.

Owners are responsible for their pets at all times and must ensure that any fouling is cleared up immediately and effectively.

Pet owners must take proper preventative treatments against worms, fleas, ticks etc.

Dogs must be kept on leads and should not present a traffic hazard

Pets must be clean and have up to date vaccinations.

Pet owners who bring their pet/s on campus must have valid third-party liability insurance and accept that they will be wholly liable for any accident for which the pet/s is/are responsible while on the School campus. School staff are entitled to ask for evidence of such insurance policies at any time.

Thought should be given to the environment that the animal has been brought up in. Large numbers of children could cause a pet to become nervous, agitated. Pets displaying any warning signs that they are becoming agitated must be immediately removed from the environment by the adult in charge of the pet.

Aggressive dogs, or those with a history of aggression, must not be brought on to the campus.

Dogs with young puppies (those under the age of eight weeks) should not be brought on to the School site as there is a risk of the mother becoming over protective, which may cause them to act out of character.

Contractors may not bring a dog onto the campus unless specifically permitted to do so by the Estates Manager.

If any staff member observes a rule being flouted, they are to remind pet owners of these rules at the first opportunity.

The School reserves the right to request that a pet be removed from their premises immediately, should it be causing any kind of nuisance, without recourse to lengthy explanations. In these instances, owners must remove their pets without delay.

5.0 Walking or Exercising Pets on Campus

The School sports fields and play areas must not be used for the purposes of exercising dogs. Dogs are not permitted on the sports pitch playing areas or designated children's playing areas. Staff and visitors should not bring their pets into the Barrovian Hall or Buchan Dining Hall, classrooms or communal areas, including staff common rooms. Some staff and pupils may have allergies or feel uncomfortable in the presence of animals. Hygiene may be compromised by the presence of animals. Public footpaths around the School can be used to walk dogs.

6.0 Pets belonging to Staff

Pets owned by staff should not normally be present when teaching or undertaking other supervisory duties.

As a school, we request that pets are not brought onto site with the intention to be left during the school day in a car in order to best protect the welfare of the pet.

Staff resident in school property are expected to ensure their pets are house trained and to do all they can to prevent pets from causing damage to school property. When pets have been in residence, staff are responsible for the professional cleaning of carpets when they leave. If there is an unacceptable degree of damage, staff will be required to make a contribution to the replacement of carpets or redecoration of the property when they vacate the property.

Staff resident in boarding houses are responsible for briefing all new members of the House about their pets. This briefing should take account of the following two issues in particular:

a) Those unused to pets (perhaps from a cultural perspective) should be reassured and given guidelines how best to react.

b) If the pet has any particular habits or behaviour that is likely to cause concerns to pupils or visitors unless they are aware, these should be made clear, with sufficient guidance given to avoid problems.

The School reserves the right to request that a pet be removed from their accommodation immediately, should it be causing any kind of nuisance, without recourse to lengthy explanations. In these instances, owners must remove their dogs without delay

7.0 Educational On/Off-Site Visits

A risk assessment will be undertaken prior to any dog being brought into the classroom, for example, for promotion of a charity.

Students will not have unsupervised access to any dog and will be told how to behave around dogs and handle safely.

Where the School has been informed that a pupil has an allergy, they will be kept away from the dog as appropriate.

Students will wash their hands thoroughly after handing the dog.

There are occasions when the presence of staff-owned dogs on educational off-site visits such as hiking trips, may enhance the experience for the pupils and staff alike. This is at the discretion of the visit leader and the member of staff responsible for approving that risk assessment. In these circumstances sensible provision must be made to transport the dog.
